## **Resolution No. 1: Digitalization of Idaho Records**

WHEREAS, a primary goal of the Idaho State Historical Records Advisory Board is to make public records more accessible to the public and the citizens of the State of Idaho; and,

WHEREAS, improved accessibility to public records is a stated goal of the Idaho Historical Society and the Public Archives and Research Library; and,

WHEREAS, the geographical diversity of the State, travel distances, and the increasing cost of travel have made it more difficult and/or impractical to visit the Idaho Public Archives and Research Library for many citizens; and,

WHEREAS, many of Idaho's citizens are now conducting research over the internet; and,

WHEREAS, numerous proposals have been made, or are available for digitalization of records at little or no cost to the Idaho Historical Society, the Public Archives and Research Library;

THEREFORE BE IT RESOLVED that the Idaho State Historical Records Advisory Board strongly supports all efforts to digitalize and index public records held by the Idaho Public Archives and Research Library, including the digitalization proposals of *Family Search Indexing, The Generations Network (Ancestry.com), The Washington State Digital Archives Multi-state Preservation Project,* and others.

BE IT FURTHER RESOLVED that a copy of this Resolution be presented to the Board of Trustees of the Idaho Historical Society, strongly urging their earliest consideration of projects aimed to achieve this goal.

## Resolution No. 2: Index of Public Records held by the Public Archives and Research Library

WHEREAS, public access to records is dependent upon knowing what records are maintained within the system; and,

WHEREAS, the index to the records of the Public Archives and Research Library are available only at the Public Archives and Research Library; and,

WHEREAS, the geographical diversity of the State, travel distances, and the increasing cost of travel have made it more difficult and/or impractical to visit the Idaho Public Archives and Research Library for many citizens; and,

WHEREAS, many of Idaho's citizens are now conducting research over the internet; and,

WHEREAS, we believe that placing this inventory online will tap a revenue source currently unavailable, since the citizens of Idaho simply do not know of their existence; and,

WHEREAS, the current inventory and index of records, although incomplete, is available in a Rediscovery® database, and that utilizing the software online would entail a licensing fee. However, the data is easily converted to Microsoft Excel® or Adobe® Portable Document Format (PDF) without payment of additional fees.

THEREFORE BE IT RESOLVED the Idaho State Historical Records Advisory Board strongly supports all efforts to place the index of public records held by the Idaho Public Archives and Research Library, including those completed by various volunteers, on the world wide web at the earliest time; and

BE IT FURTHER RESOLVED that the Idaho State Historical Records Advisory Board urges the Trustees of the Idaho Historical Society to consider action necessary to make this information available online for all citizens of the State of Idaho, including the Rediscovery® and other data indexes.
