Steve Walker introduces 2 new members to the SHRAB board, Tom Terrall and Clete Edmunson

#### 9:40 Status of the SHRAB grant – Steve Walker

Steve announces that the current grant will end on June 30<sup>th</sup>, 2007 and that SHRAB had meant all objectives.

With all the dedicated work that went in into securing the next years NHPRC funding, Carter Wilson was able to write (electronic format) and send it in before the deadline. Carter also gave SHRAB the details on how the process worked

Steve Walker presented the new objectives for this year grant funds. The objectives will include the ongoing training/ workshops throughout the State of Idaho.

Steve Walker and Linda Morton-Keithley gave an update on their recent \$75,000 grant they received for ISHS project on inmate records, which will start in July of 2007.

Steve Walker explain to SHRAB about the new technology of scanning images for which ISHS also received funding to purchase new equipment.

Denton Darrington had asked questions about the project on inmate records, Question: What was the number of inmate records that were turned over to ISHS.

Duane Bogstie gave a brief discussion on the numbers of boxes of inmate records that are turned over to ISHS.

Normally IDOC will request 20 to 30 boxes per year to go back to them for inventory before being transferred over to State Archives.

Steve Walker and Duane Bogstie Discuss the New Email Guidelines that are now approved for all state agencies to follow. Discussions followed on if City and Counties will use the State email guidelines.
