DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Twin Falls City Park Historic District includes the area which surrounds the city park, with the exception of those locations containing structures erected in the past thirty years. (Most notably the land between the Christian Church (10) and St. Edwards Roman Catholic Church (1), between the Methodist Church (8) and Doctor J. N. Davis' office building (5), and between the Lester T. Wright residence (2) and Fifth Avenue East.

Besides the park with its lava rock bandstand (7) and mature trees, the district includes five churches, two apartments, two professional offices, the county courthouse and judicial building, the public library, the former American Legion hall, and the former high school. This high density of community related structures distinguishes the district from the surrounding residential and commercial areas.

The buildings primarily date between 1909-1920, although several were erected in the late twenties and thirties. None are more than three stories high and most are two, with brick being the predominant building material. United by their scale, age and function, the buildings create a cohesive environment while presenting a diversity of styles typical of the period and region. The Spanish mission, Gothic, bungalow and neo-classical are the major styles represented. The proximity of the park allows for landscaped views, an advantage further capitalized upon by the large lawns surrounding the courthouse (15) and high school (11).

The district is in good condition and with the exception of the judicial building (14) is free from intrusions. Although two churches have been removed for commercial parking purposes, the area still retains much of its original character and function.

Inventory of buildings:

1. Saint Edwards Catholic Church is one of the best examples of the Renaissance revival style in the state and is distinguished by its twin 75' towers, terra cotta exterior and scagliola ornamented interior. Constructed in 1920-1921, for \$60,000, it was designed by local architect Ernest H. Gates.
2. The Lester T. Wright residence is a brick bungalow with prairie style influences which has been converted into professional offices. Originally built in 1909 for \$7,000, this seven room dwelling was converted into offices for Doctor Lamb in the 1920's. Since World War II it has been used as a law office.
3. The public library is a classically inspired one story brick building which was constructed in 1939.
4. The Reformed Church is the only frame structure in the district, built in the bungalow style. It was constructed in 1909 as the Christian Church, and sold to the Lutherans in 1929.
5. Doctor J. N. Davis' residence and office is a one-story, smooth stucco, Spanish mission style building with fine round arched, beveled glass entries. It dates from 1938.

STATEMENT OF SIGNIFICANCE

The Twin Falls City Park Historic District is architecturally significant for its inclusion of many of the city's (and several of the state's) finest ecclesiastical and public buildings.

The Twin Falls Land and Water Company platted the city in 1904 as a part of their Carey Act Project. Four blocks, including the present sites of the park, high school and county courthouse, were set aside at this time for park purposes. When Twin Falls became a county seat in 1907 the area west of Shoshone Street was employed for the courthouse and high school sites. The area surrounding the park became the prime location for various churches and the vacant lots were tacitly "reserved" for important community structures. By 1925 the Twin Falls Daily Times had proclaimed "Beauty Spot Rapidly Becoming Twin Falls' Community Center" in reference to the city park area. By this time five churches were standing with the Christian and LDS churches planning to build. The courthouse and high school were present, the city already owned the library site, and there was some talk of erecting a Y.M.C.A. building on the corner now occupied by the American Legion and Doctor Davis buildings. This high density of community related structures centering about the park is highly reminiscent of New England town greens, and serves as an example of its adaptation in early twentieth century urban planning.



6. The American Legion hall is a one-story brick building in the moderne style distinguished by its good brickwork. Besides housing the American Legion, it also served as an armory and community hall. It was constructed in 1928 and is presently owned by the Health Department.
7. The lava rock bandshell in the park was a WPA project of the early 1930's.
8. The Methodist church is a sandstone building in the Gothic style with fine stained glass windows. Originally constructed in 1908 of brick, it assumed its present appearance in a 1916 remodeling. Architect B. Morgan Nesbit was in charge of the remodeling which removed a corner belfry and provided for an auditorium seating 1150. A brick and concrete addition was placed on the south side in recent years.
9. The Rex Apartment block is a three-story brick apartment building in the neo-classical style. Constructed in 1918, this \$45,000 building was designed by Burton E. Morse, Twin Falls' pioneer architect.
10. The First Christian Church is a neo-classical revival style church distinguished by its pedimented portico with Doric columns. It was constructed in 1929 and was designed by Portland architect Taymond W. Hatch, who also designed the First Christian Church in Lewiston.
11. The neo-classical revival high school building cost \$150,000 to construct in 1910-1912. Designed by Wayland and Fennell of Boise, this brick building has sandstone trim and originally terminated with a dome. Its grounds were laid out by Hugh Bryan a Portland landscape architect.
12. The Presbyterian Church is a classically inspired building constructed of Denver "Turkey shade" brick. It cost \$25,000 to build in 1916 and was designed by local architect John Visser.
13. The Justamere Inn is a two-story, Spanish mission style building which was built in 1910. It was originally a hotel, and now serves as low income housing for the elderly. It is in good condition, closely resembling original appearance.
14. The Twin Falls judicial building is the only intrusion in this district. It is a one-story brick building of a utilitarian design and dates from 1969.
15. The Twin Falls county courthouse is a three-story neo-classical revival building constructed of yellow brick with stone columns and cornices. It is distinguished by a round arched entry with a pedimented portico supported by Ionic columns. The original mahogany and oak interior is still intact. It was the tallest building in Twin Falls (constructed in 1909-1910) and boasted the city's first elevator. Local architect C. Harvey Smith designed this building.
